1 Scope

GB/T 1209.2-2009 is the Chinese national standard on agricultural machinery - cutter bars - part 2: guard, in the field of agriculture. The /T suffix marks it as a recommended standard: it is not compulsory by itself, but it becomes binding as soon as a contract, a tender or a customer specification calls it up - which in practice is how most foreign buyers meet it. It was issued on 30 November 2009 by the General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China; Standardization Administration of China, and has been in force since 1 April 2010. Classification: ICS 65.060.50, CCS B91. This page is published from the official record of the standard held by the Chinese standards administration: the identification, the dates, the classification and the issuing body are taken from there. 3 Types and basic dimensions

3.1 blade protection is divided into five types. I type

--- suitable for I type cutter; II type

--- suitable type II cutter; III type

--- suitable for III type cutter; IV type

--- suitable IV type cutter; V type

--- suitable for V type cutter.

3.2 Blade guard the basic types and dimensions shall comply with Figs. 1 to 5. V type blade guard Single, pole holder and retaining the tongue in Appendix A.
