1 Scope

GB/T 1335.2-2008 is the Chinese national standard on standard sizing systems for

garments - women, in the field of clothing industry. The /T suffix marks it as a recommended standard: it is not compulsory by itself, but it becomes binding as soon as a contract, a tender or a customer specification calls it up - which in practice is how most foreign buyers meet it. It was issued on 31 December 2008 by the General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China; Standardization Administration of China, and has been in force since 1 August 2009. Classification: ICS 61.020, CCS Y75. This page is published from the official record of the standard held by the Chinese standards administration: the identification, the dates, the classification and the issuing body are taken from there. 3 Terms and Definitions

GB/T 16160 and established the following terms and definitions apply GB/T 1335 this part.

3.1 Body height, expressed in centimeters, is the design and purchase of clothing length basis.

3.2 The body's upper body or lower body waist bust, expressed in centimeters, is the design and purchase of clothing too fat basis.

3.3 In margin of the human body as the basis bust and waist divided body type. Body is divided into four categories, classification code-named Y, A, B, C. Size classification code as follows:

- a) Y represents the difference between the number of bust size and waist circumference in between 19cm ~ 24cm.
- b) A body representing the difference in the number of bust and waist circumference between 14cm ~ 18cm.

c) B represents the difference between the number of bust size and waist circumference in 9cm ~ 13cm between.

d) C number represents the difference between bust size and waist circumference at 4cm between ~ 8cm.

4 Requirements

4.1.2 height to 5cm tranches composition series.

4.1.3 Bust to 4cm tranches composition series.

4.1.4 waist to 4cm, 2cm tranches composition series.
