1 Scope

GB/T 15670.4-2017 is the Chinese national standard on toxicological test methods for pesticides registration - part 4:acute oral toxicity test - miller and taninter's method, in the field of agriculture. The /T suffix marks it as a recommended standard: it is not compulsory by itself, but it becomes binding as soon as a contract, a tender or a customer specification calls it up - which in practice is how most foreign buyers meet it. It was issued on 12 July 2017 by the General Administration of Quality Supervision, Inspection and Quarantine of

the People's Republic of China; Standardization Administration of China, and has been in force since 1 February 2018. Classification: ICS 65.100, CCS B17. This page is published from the official record of the standard held by the Chinese standards administration: the identification, the dates, the classification and the issuing body are taken from there. The clause text, the tables and the numeric limits are in the document itself, which is delivered complete in English translation.

This section GB/T 15670 specifies the basic principles, methods and requirements of the acute oral toxicity test probability unit method. This section applies to pesticides registered acute oral toxicity test.

3 Terms and definitions

The following terms and definitions apply to this document.

3.1 Acute oral toxicity of acuteoraltotoxicity The effects of health damage to animals in the short term after one or more oral administration of the test animal substance within 24 hours.

3.2 Dose dose The amount of test substance given is expressed as mass of test article received per unit body weight of test animal (mg/kg body weight).

3.3 Median lethal dose medianlethaldose LD

50 Once or within 24 hours of repeated administration of test animal compounds, the overall experimental animals caused half of the total dose of toxicants statistics. The test animal's body weight to accept the test substance mass (mg/kg body weight).

3.4 Dose-response relationship dose-responserelationship Relationship between dose and incidence of specific effects.
