--- Remove belonging to process control "solid density" (see 1998 edition 4.2)

--- Remove belonging to process control "dot gain" (see 1998 edition 4.6);

--- On the "Indian face look" made appropriate modifications (see 51, 1998, version 4.1.);

--- On the "overprint error" made the appropriate changes (see 52, 1998. Version 4.4.);

--- On the "same batch color difference" made appropriate modifications (see 53, 1998, version 4.5.);

It was issued on 31 December 2012 by the General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China; Standardization Administration of China, and has been in force since 1 June 2013.
