1 Scope

GB/T 22678-2008 is the Chinese national standard on electric saber saws, in the field of manufacturing engineering. The /T suffix marks it as a recommended standard: it is not compulsory by itself, but it becomes binding as soon as a contract, a tender or a customer specification calls it up - which in practice is how most foreign buyers meet it. It was issued on 31 December 2008 by the General Administration of Quality Supervision, Inspection and Quarantine of the People's Republic of China; Standardization Administration of China, and has been in force since 1 October 2009. Classification: ICS 25.140.20, CCS K64. This page is published from the official record of the standard held by the Chinese standards administration: the identification, the dates, the classification and the issuing body are taken from there. The clause text, the tables and the numeric limits are in the document itself, which is delivered complete in English translation.

This standard specifies the basic parameters of electric saws, type, technical requirements, test methods and inspection rules and other requirements. This standard applies to general environmental conditions, wood, metal, plastic, rubber and similar materials, sheet and tube, straight line sawing The single-phase AC and DC series motor or hand-held power saws (hereinafter referred to as saber saws). This standard also applies to electronic speed saws and knives. This standard does not apply to jigsaw, Portable electric sawing machine and cordless reciprocating saw.
