--- Added 1.1.2, 1.1.3, 1.3, 1.101 and 4.2, which correspond to the content of the corresponding clauses of GB/T 4214.1-2017, and are compatible with other ministries

The structure of points is unified;

---Added the explanation that Appendix B is not applicable, GB/T 4214.1-2017 Appendix B does not apply to this document.

This document has made the following editorial changes.

---In order to be consistent with the existing standard series, the standard name is changed to "Household and similar electrical appliances noise test methods, electric food processing Special requirements for appliances.

Introduction

GB/T 4214 "Household and similar electrical appliances noise test method" series of national standards adopt IEC 60704 series of international standards.

---Special requirements for electric shavers (GB/T 4214.5). The purpose is to propose a special noise test method for electric shavers

---The procedure for determining and verifying the explicit value of noise (GB/T 4214.10). The purpose is to give all the product identification and inspection noise

The use of IEC 60704-3 provides a basis for the determination and inspection of the noise explicit value of other parts of the entire series of standards.
