Introduction

In order to guide the construction of smart factories in a systematic manner according to scientific methods and rules, and guide enterprises to Gradually develop towards high-level smart factories, thereby promoting the transformation and upgrading of manufacturing enterprises, and formulate GB/T 43064 "Guidelines for the Construction of Smart Factories" GB/T 43064 is intended to solve the common problems encountered by enterprises in the process of building smart factories. - Part 3: Requirements for integration of virtual factories and physical factories. The purpose is to specify the requirements for integration of virtual factories and physical factories in the construction of smart factories.

The overall framework and technical architecture of the factory integration, and the integration content, data standards, integration interfaces, system implementation, system

operation, etc. Provide technical guidance.

- Part 4: Preparation of smart factory design documents. The purpose is to standardize the construction, reconstruction, expansion and technical Preparation of design documents in the design of technological transformation projects.

Guidelines for building smart factories Part 4: Preparation of smart factory design documentation

1 Scope

This document specifies the content and requirements for document preparation at each design stage of smart factory construction projects.

This document is applicable to the preparation of design documents for new construction, renovation, expansion and technological transformation projects of smart factories.
